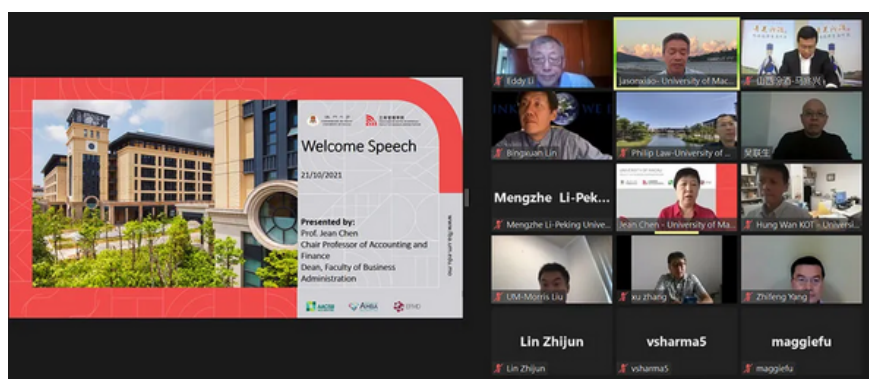

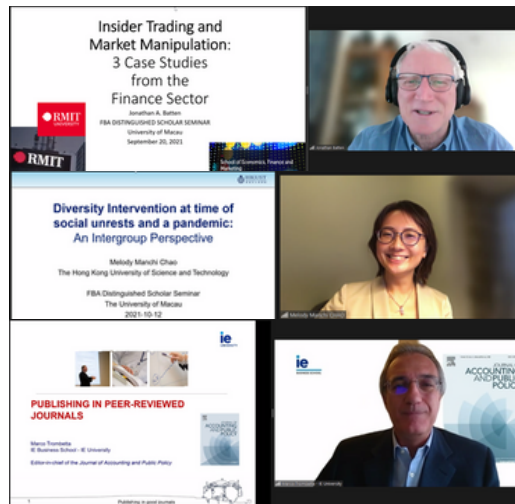
FBA successfully hosted an SME Business Forum 2021
