### HIGH QUALITY RESEARCH OUTPUT

FBA encourages and supports high quality research. Our colleagues continue to publish their research in leading journals. We would like to share with you the following works of our researchers who recently published ABS4\*, ABS4, FT50, UTD articles.

**Prof. Rachel Xiaorong MA (馬笑蓉教授),** Assistant Professor in the Department of Finance and Business Economics, published an article entitled "RegTech Adoption and the Cost of Capital. Management Science" in collaboration with **Prof. Sandy LAI and Prof. Chen LIN**, in Management Science (ABS4\*, UTD, FT50).

### Paper abstract:

This paper studies the cost of capital effect of a major regulatory technology, or RegTech, event: the staggered implementation of the Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system of the Securities and Exchange Commission in the period from 1993 to 1996. This event represents a largely exogenous shock to corporate information dissemination technologies, resulting in a considerable reduction in information acquisition costs for investors. Using a difference-in-differences research design, we show that the cost of equity capital declines substantially after a firm switches from paper filing to mandatory electronic filing in EDGAR. The effect is stronger for small firms and firms with low analyst coverage and low institutional ownership. We identify three channels through which EDGAR affects a firm's cost of capital: the liquidity, risk-taking, and corporate governance channels. EDGAR implementation also improves a firm's investment efficiency significantly. We find evidence that the marginal value of a firm's capital investment and cash is higher during the post-EDGAR period.

**Prof. Li MIAO (苗莉教授)**, Professor in the Department of Integrated Resort and Tourism Management, published an article entitled "The impact of knowledge hiding on targets' knowledge sharing with perpetrators" in collaboration with **Prof. Meizhen LIN** and **Ms. Yue LI**, in Tourism Management (ABS4).

#### Paper abstract:

Using a sequential mixed-methods approach, this study explored how knowledge hiding (KH) targets react to perpetrators in the hospitality industry. Study 1 entailed in-depth interviews of 20 employees from 13 hotels. Findings indicate that KH influences knowledge transfer behavior through negative emotions. Moreover, individual personality and motivation, team and interpersonal factors, job characteristics, and KH characteristics can moderate this effect. In Studies 2 (n = 54) and 3 (n = 118), two scenario-based experiments reveal that KH negatively affects targets' knowledge sharing (KS) with perpetrators directly and indirectly through negative emotions. In Study 4, the results of a survey from 475 employees indicate that when the need for affiliation of employees and task interdependence is high, the negative effect of negative emotions on KS with perpetrators is weaker. This study advances the literature on KH by offering a sound theoretical treatment of emotional concerns and the interaction between knowledge seekers and knowledge hiders.

Prof. Rob LAW (羅振雄教授), UMDF Chair Professor of Smart Tourism, published an article entitled "Power of Sentiment Expressions on Peer-to-Peer Rental Platforms: A Mixed-Method Approach" in collaboration with Prof. Xi ZHANG, Prof. Xin WEI, Prof. Te ZHANG, Prof. Sai LIANG and Prof. Yao MA, in Journal of Travel Research (ABS4).

#### Paper abstract:

Studies have confirmed the ineffectiveness of sentiment expressions generated by sellers in improving guests' purchasing intentions. However, how sentiment expressions can influence guest behavior and host performance remains unclear, given the relative importance of seller-generated content in peer-to-peer rental platforms. After collecting data from Airbnb and developing empirical models, this study confirmed that hosts' sentiment expressions largely benefit from their online performance. This case is especially true when their properties did not receive high-quality negative reviews. To further reveal the mechanism behind this effect, we further conducted two experiments. Results show that trust plays an intermediary role in the relationship between hosts' sentiment expressions and guests' purchasing intentions. This work contributes to tourism literature and property owners on peer-to-peer rental platforms in practice.

Prof. Fiona Xi YANG (楊曦教授), Assistant Professor in the Department of Integrated Resort and Tourism Management, and Prof. Anthony Ip Kin WONG (黃業堅教授), Professor in the Department of Integrated Resort and Tourism Management published an article entitled "Kindness for kindness: A dual appraisal of international support in response to COVID-19" in collaboration with Prof. X. Li, Mr. B. Cai and Prof. X. Xiong, in Journal of Travel Research (ABS4).

### Paper abstract:

A friend in need is a friend indeed" well elucidates international support amid the COVID-19 pandemic. Drawing on a dualprocess model of emotional appraisal, this mixed-methods research aims to investigate positive psychological responses to international support. Study 1 is a multilevel investigation of the relationships between perceived support, gratitude evoked, and change in attitude toward the benefactor countries. The moderating role of motivational relevance-the province-level prevalence of COVID-19-is also examined. Study 2 uses text mining to analyze online reviews retrieved from a social media platform. The results substantiate aid-induced gratitude and reciprocity manifested through travel intentions and unravel additional factors of motivational relevance-timing, type of support, political and cultural connotations, and comparative appraisals. Study 3 employs an experimental design to validate the causal relationships and reinforces the dual-appraisal mechanism. Managerial implications are provided for destination marketers and industry practitioners to leverage positive psychology for post-pandemic promotion.

The Business Research and Training Center (BRTC) of the Faculty of Business Administration (FBA), University of Macau (UM) has successfully completed the 3rd batch of International Financial Reporting Standards (IFRS) professional training, which took place over four consecutive weekends in May 2023 at the university campus.

IFRS is a set of accounting standards developed by the International Accounting Standards Board (IASB) to ensure financial reporting transparency and comparability across different countries. The two distinct topics of this series – IFRS 2 (Share-based Payment) and IFRS 5 (Non-current Assets Held for Sale and Discontinued Operations) have attracted over 80 registrations, consisting of senior auditors and partners from Big 4 and other local accounting firms, financial analysts and top executives from financial institutions, as well as practitioners from the public, utilities and gaming sectors.

The executive training was conducted by experienced IFRS trainers, including **Prof. Morris LIU (劉明教授)** and **Mr. Derek CHAN (陳永亨導師)** (both from UM), who are experts in the field. During the training sessions, participants received interactive guidance on case studies and demonstration of real-life disclosure examples to gain a deeper understanding on the practical application of these standards in the real-world scenarios. Upon completion of the training sessions, participants will receive certificates issued by UM and the Professional Committee of Accountants (CPC) of Macau.
